How long do we keep your data?

10XCREW does not store your personal data longer than is strictly necessary to achieve the goals for which your data is collected.

- Identification data: at least 5 years after the end of the agreement
- Location data: up to 1 year after the end of the agreement
- Website statistics and behavioural data: 26 months

SHARING PERSONAL DATA WITH THIRD PARTIES

10XCREW does not sell your data to third parties and only provides it if necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a contract with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. 10XCREW remains responsible for these processing operations.

COOKIES

10XCREW only uses functional cookies on <https://rewards.logitech.com>. Cookies are text files that are stored on your computer or mobile device when you visit the website. 10XCREW uses cookies with a purely functional functionality. These make sure the website works properly. No cookies are stored during and after your visit.
